TRUSTEES' REPORT For the year ended 31 December 2004

The Trustees submit their annual report and the financial statements of British Union Conference of Seventh-day Adventists (the charity) for the year ended 31 December 2004. The Trustees confirm that the annual report and financial statements of the charity comply with current statutory requirements, the requirements of the charity's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in October 2000.

The trustees also confirm that, where these do not conflict with statutory requirements, the financial statements are prepared in harmony with the accounting principles and practice of the General Conference of Seventh-day Adventists, as provided for in the Charity's constitution.

The attached financial statements are those of the charity alone. The consolidated financial statements of the charity and its subsidiary enterprises are published as a separate document.

Method of appointment or election of Trustees

The management of the charity is the responsibility of the Trustees who are elected and co-opted under the terms of the written constitution.

The executive committee members - its trustees for the purpose of the Charities Act 1993 - are elected/re-elected every five years at the occasion of the Charity's general assembly (Session), by delegates chosen from the various Seventh-day Adventist organisations and church congregations in the Charity's territory. The administrative officers (president, executive secretary, and treasurer) are also elected at the Session and are ex-officio members of the executive committee. They are charged with working with, and accounting to the executive committee for the day-to-day operation of the Charity. Between Sessions the trustees, through the vehicle of the executive committee, generally determine all matters of substance relating to the life and work of the Charity.

Trustees serving during the year are shown on the Legal and Administrative page.

The Charity's constitution provides for employed trustees, requiring that their remuneration rates and expense budgets be determined annually by a 'Remuneration Audit Committee' made up of non-trustees, and acting independently of the trustees. The executive committee may reduce (but not increase) the remuneration and expense levels so determined. No trustee received emoluments in excess of £30,000.00 for the year.

Constitution policies and objectives

The British Union Conference of Seventh-day Adventists ("the Charity") is registered in England as a charity (No. 1044071) with its offices situated at Stanborough Park, Watford, Hertfordshire, WD25 9JZ. The Charity is an unincorporated association, whose governing instrument is its Constitution, and which is administered by a Board of Trustees ("the executive committee").

The principal object of the charity is to provide support to local congregations and local conferences of congregations of Seventh-day Adventists within the British Isles.

There have been no changes in the objectives since the last annual report.

Organisational structure and decision making

The Charity is the principal administrative body of the Seventh-day Adventist Church ("the church") for the United Kingdom and Republic of Ireland. It generally works in harmony with the policies of the church's international office, the General Conference of Seventh-day Adventists, Trans-European Division, situated at St Albans, Herts

Within its territory, the Charity carries out its objects both directly and through related organisations. Principally, the latter consist of three 'Missions' in Ireland, Scotland and Wales respectively (all branches of, and financially dependant upon the Charity), and two 'Conferences' in North and South England respectively (both registered charities in their own right and financially self-supporting).

Within these latter organisations the objects are pursued mainly through a network of local churches which are heavily dependent upon a large pool of voluntary lay support.

The following organisations have been charged with certain aspects of the charity's operations:

- § Seventh-day Adventist Trust Company (Executor for Charity Members)
- § The Stanborough Press Limited (Publishers)
- § Stanborough School (Primary, Secondary and Boarding School)

Review of activities and future developments

The church experienced a net growth in church membership of 1,105 taking its total membership figure at 31 December 2004 to 24,234. This represented a 4.78% growth rate for the year and was slightly down on the previous year. Growth continued to benefit from significant numbers of Seventh-day Adventists coming to live in the UK and the Republic of Ireland from overseas. The net transfer growth during the year stood at 628 - the highest annual figure to date. This has presented the church with the challenging opportunity of helping local churches to extend a warm and meaningful fellowship to these new members coming from many diverse cultural backgrounds. The Communication director wrote and implemented a major new membership database system for the whole church in the UK and the Republic of Ireland. This combined two separate membership databases thus reducing duplication of data and work.

In harmony with its strategic plan the British Union Conference's Ministerial Association continued to promote, develop and implement the LIFEdevelopment.info initiative and resource materials. This strategy is designed to help the church to communicate the Christian gospel effectively in the largely post-modern society where a large majority of the population do not attend church.

Emphasis during the year was placed on producing two series of television programmes entitle 'Evidence' and 'Mind the Gap'. The ten part 'Evidence' series was an innovative magazine style presentation each focusing on a different lifestyle value that was televised live from Newbold College, Bracknell, Berks, in March via satellite transmission. The ten programmes in the 'Mind the Gap' series which explored basic Christian themes in a discussion forum format were recorded during July with plans to have them transmitted in February 2005. A study guide was produced for the 'Mind the Gap' presentations and both programmes were produced in DVD format for use by church members. Five further issues of the new style LIFE.info magazine, launched in autumn 2002, rolled out in 2004 with a total print run of 352,000 copies as support material to run along side the satellite programmes.

Following discussions with the church's world headquarters transmission of the church's two 24/7 satellite broadcast programmes became available via the Hotbird satellite from 1 January 2004 to members and the general public who had the appropriate reception equipment. This has provided worship, training and outreach resources to Adventist churches and members in the British Isles. The Communication department, which is responsible for the running of the BUC MEDIA Centre, produced several short programmes and submitted other footage for use on one of the channels.

Working directly with pastors and congregations in Ireland, Scotland and Wales, and in a co-operative role with the South and North England Conferences the Personal Ministries department supported the strategic plan by focusing on five primary areas of activity developing resources and organising meetings for:

1. Training in home-based small group formation for the purpose of community-building, personal growth, spiritual formation and service to the wider community.
2. Facilitating the recognition and development of personal skills and gifts through discipleship workshops for the purpose of increasing the level of involvement of members in the life of the local church.
3. Promotion and training in the concepts of contemporary church-planting for the purpose of making the services of the church available to a wider cross-section of cultural groups within the UK.
4. Revitalising existing congregations for the purpose of raising awareness of community needs and the potential of such congregations to serve one or more of those needs.
5. Assisting ADRA (Adventist Development and Relief Agency) director in promoting and organising events for the annual public fund-raising appeal.

The second annual UK Church Planters' Exchange was held in February, attracting almost double the number of attendees compared with the previous year. The year also saw the introduction of two new church planting training programmes: the 6-part training "Matrix" for denominational leaders, and the bi-monthly NCI (New Church Incubators) one-day training events for new church planting teams. Among other things, this matrix has led to the creation of a system of assessment to identify the strengths and weaknesses of future church planters, plus a coaching network to provide ongoing support for active church planting teams.

LIFEdevelopment.info provided the larger context throughout 2004 for over 20 local one-day and residential weekend training events in activities 1 - 4 listed above. A total of more than 600 pastors and church members participated in these events.

No development took place in the materials and services provided by the Adventist Discovery Centre pending the appointment of a new manager.

During the year the Education Department continued to provide strategic development, support and monitoring to the heads and governing bodies of the primary and secondary schools operated by the charity and its related organisations in the UK and Republic of Ireland. This included assistance in the preparation for Ofsted Inspections, secondary curriculum development and INSET training.

A variety of health programmes for Church members and the general public in a range of settings across the United Kingdom were facilitated by the Health Ministries Director. These include: Carmarthen, SEC Weekend Health Retreat (Staverton Park), Welsh Mission Weekend Health Retreat (near Cardiff), Muswell Hill; four-night Health-Risk Reduction series at Nuneaton, Yardley, Huddersfield, Oxford (vegetarian dining club), Newbold College (Mentoring and Empowerment weekend with Drs K Kuntaraff and G Hopkins), Canterbury, Worthing, Peckham, and Amersham (one-day stress programme). The director participated in: the Loma Linda/GC Nursing Convention held at Coventry; a conference on Alcohol and Family Violence held at Northampton; the programmes of the Adventist International Medical Society held at Newbold College; and as the guest speaker for the Polish Union summer programmes held in the North and South of Poland during the month of August presenting Health-Risk Reduction measure, and special topics for the workers involved in the programmes.

As part of the net-working with other organisations the health ministries director took part in conferences organised by the Royal Society of Medicine, the Institute of Health Promotion and Education, and at two youth seminars held by the United Kingdom Alliance at the House of Commons on the topics of alcohol and drug prevention. Regular articles on various aspects of health have been published in the Messenger and Focus magazines and a book on Stress was prepared for publication by the Stanborough Press.

The Woman's Ministries department continued to experience significant growth in demand for its services and resources. Each Women's Ministries leader in the local church receive a manual, while the Adventist Woman magazine and retreat workshops addressed such issues as mentoring, sexuality, lone parenting, self-development, depression and conflict management. Leadership training was enhanced by the addition of a second tier Certificate II level programme that builds on the skills developed under the existing level one Certificate. The 'HeartCall' project, which seeks to reconnect those no longer attending church remained the focus of the department's evangelistic thrust. This was supported by the promotion of prayer ministries as an integral part of any outreach activity. A set of prayer posters "Take it to the Lord in prayer" were sent to each local congregation.

Every local church children's department received a quarterly newsletter highlighting: a children's prayer ministry, the need for male role models, promoted KCFS training and encouraged children's outreach. In addition two resource manuals were produced and the material was subsequently transferred onto disc format to reduce production and distribution costs. An 18-month promotion of child evangelism commenced in the autumn to help adults recognise the need to provide spiritual nurture from an early age and to equip children to share their faith. The BUC Child Protection (KCFS) policy was reviewed and updated by the NSPCC and training workshops were organised.

The Family Ministries department continued to provide a co-ordinating role to subsidiary units.

The Youth Department is endeavouring to bring youth ministry into the twenty-first century through the constant appraisal of the effectiveness of its resources. The task was not made easy by the changes in administration in the youth department throughout the territory. In addition to the regular and very successful ministry to the 5-15 years old through the Adventurer and Pathfinder programme, focus was given to heightening the importance of the ministry to the teenagers within its territory for whom the Pathfinder programme has limited interest. During July the department organised a nation-wide Pathfinder Camporee at which 779 participants were present from clubs throughout the United Kingdom and the Republic of Ireland.

Interest in volunteer services was fostered by hosting a project in Ghana in which 45 persons assisted to build a community hospital during June and July. Primary funding was provided by ADRA-UK, but each individual volunteer also contributed substantially to the project. Thousands of pounds worth of medical assistance was given to the hospital from the church and other organisations in the UK. A medical ministry to the people of Tamale was run concurrently and schools were visited to assist with health education for students. As a separate venture the volunteers conducted three evangelistic programmes during which thirty-five people were baptised.

Ministry for the young adults or senior youth continued to prove challenging to the church. However, a joint Youth Congress held in Poland in July was attended by over 100 young people from the church in the UK.

During the year the Communication department carried out the following core functions:

1. Providing news. This is done through the weekly email newsletter, BUC News, the Messenger, and occasional news releases. BUC News is sent to around 1,500 people each Friday.
2. Creating and maintaining official websites. The British Union Conference now runs several websites, which provide information about the Seventh-day Adventist Church in the United Kingdom and Ireland. Functions of these sites include news and information, historical archives, and databases of events, churches, and preaching plan information. In addition the Communication department maintains the ADRA-UK and LIFEdevelopment websites. Altogether there are around 10,000 files, which are maintained on these sites.

3. Running workshops and training. This year two professional training events were run in conjunction with the South England Conference.
4. Maintaining the office information infrastructure.
5. Marketing and Public Relations. Thousands of leaflets, booklets, or information packs and hundreds of promotional items such as pens and key rings were distributed. Display materials are provided on a loan basis to churches running shows or exhibitions.

The Ministerial Department hosted a Spiritual Retreat for all church based employees in the United Kingdom and the Republic of Ireland at the beginning of the year. Presentations included a varied series of workshops and plenary sessions related to the implementation of the above strategic plan.

Finance report

The British Union Conference continued to be supported by its constituent charities, the South and North England Conferences, the churches in Ireland, Scotland and Wales. We are also in a mutual supportive relationship with the General Conference of Seventh-day Adventists through the Trans-European Division.

Tithe - the major source of our income grew by 5.9% (7.2%) overall during 2004 (2003). Direct tithe to the Irish Scottish and Welsh missions grew at a slower rate this year.

The total tithe contributed by members (including to the associated North England and South England conferences) was in the region of £12.75 million. This reflects increased stewardship by our members, and the increase in membership attendance. The church continues to benefit from new members arriving from various parts of Africa and Europe reflecting national migration trends this was less pronounced in 2004.

Gift Aid continues to be a valued and successful resource for our Conference, Mission and local Church operations.

The production of two television broadcasts series of ten programs each was a major event and cost of the year. The goal was to contextualise the message and values of Christianity for the needs of a post-modern public. Both series have been aired on the Hope Channel with DVD version being available for distribution.

Further progress was made in dealing with the challenges of our pension fund. Whilst the funds accessible to the Trustees show a deficit, the asset profile and particularly unencumbered property portfolio of the British Union and its associated charities is more than sufficient to guarantee the ultimate requirements of our pension commitments.

The operation of our church is people intensive. Most of our employees are Ministers of Religion who further the work of the church through proclamation, education, nurture and community building activities. They also operate as co-ordinators for the voluntary activities of our members within the church and the community at large. The British Union in particular serves as a leadership, people resource and support platform. Management and Administration is thus in the nature of what we do, although the costs of technical administration is kept to a minimum.

Reserves policy

The trustees evaluated the charity's risk exposure. We consider that a combined general reserve of £2million is appropriate. We have particular commercial challenges with our operations in the Nursing and Health sector and anticipate large maintenance requirements at our School in Watford. We consider that a general reserve of £1.725 million would still be appropriate.

Risk management

The Trustees have assessed the major risks to which the charity is exposed, in particular those related to the operations and finances of the charity, and are satisfied that systems are in place to mitigate our exposure to the major risks.

Operations of subsidiary organisations

Stanborough School represents a major property investment on our home estate. The secondary school building is 10 years old and is suffering from its first natural replacement of fittings cycle which is likely to require significant resources. The primary school was built with a life expectancy of 30 years, and now operates by grace. Replacement of the roof, window, doors and drains are imminent contingencies.

The Stanborough Press has instituted operational efficiencies and is competing strongly in the African market where the church is expanding significantly. They continue to produce new books that are being well received. The major risks are the vagaries of currency exchanges and the low margins that can be expected in the markets we serve. This institution has filed a surplus in its operational accounts.

The Good Health Association discontinued Nursing Care in Scotland. Expansion of the Health Improvement program has expanded but has not yet reached break even.

The House to House collection in the name of ADRA-UK was particularly successful. Funds were transferred to the projects named within 3 months and reports are now available on the success of these development programs. The charity won 3 contracts from the British Department for International Development and 3 from the European Union. Church members made a significant contribution to Disaster relief associated with the Asian Tsunami.

Trustees' responsibilities

Law applicable to charities in England/Wales requires the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the surplus or deficit of the charity for that period. In preparing those financial statements the Trustees have:

- selected suitable accounting policies and applied them consistently;
- made judgements and estimates that are reasonable and prudent;
- stated whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepared the financial statements on a going concern basis (unless it is inappropriate to presume that the Trust will continue in operation).

The Trustees have overall responsibility for ensuring that the charity has an appropriate system of controls, financial and otherwise. They are also responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 1993. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the detection and prevention of fraud and other irregularities.

INDEPENDENT AUDITORS' REPORT TO THE TRUSTEES OF BRITISH UNION CONFERENCE OF SEVENTH-DAY ADVENTISTS

We have audited the financial statements of British Union Conference of Seventh-day Adventists for the year ended 31 December 2004 which comprise the Statement of Financial Activities, Balance Sheet and Cash Flow Statement, with the related notes. These financial statements have been prepared under the historical cost convention and the accounting policies set out therein.

RESPECTIVE RESPONSIBILITIES OF THE TRUSTEES AND AUDITORS

As described in the Statement of Trustees' Responsibilities the Trustees are responsible for the preparation of the financial statements in accordance with applicable law and United Kingdom Accounting Standards.

Our responsibility is to form an independent opinion, based on our audit, on those statements and to report our opinion to you. We have been appointed auditors under Section 43 of the Charities Act 1993 and report in accordance with regulations made under Section 44 of that Act.

We report to you our opinion as to whether the financial statements give a true and fair view and are properly prepared in accordance with the Charities Act 1993 and the Statement of Recommended Practice (SORP), "Accounting and Reporting by Charities", published in October 2000. We also report to you if, in our opinion, the Trustees' Report is not consistent with the financial statements, if the charity has not kept proper accounting records, if we have not received all the information and explanations we require for our audit, or if information specified by law regarding Trustees' remuneration and transactions with the charity is not disclosed.

We read the Trustees' report and consider the implications for our report if we become aware of any apparent misstatements within it.

BASIS OF AUDIT OPINION

We conducted our audit in accordance with United Kingdom Auditing Standards issued by the Auditing Practices Board. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgements made by the Trustees in the preparation of the financial statements, and of whether the accounting policies are appropriate to the charity's circumstances, consistently applied and adequately disclosed.

We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. In forming our opinion we also evaluated the overall adequacy of the presentation of information in the financial statements.

NOTES TO THE FINANCIAL STATEMENTS For the year ended 31 December 2004

1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention, with the exception of investments which are included at market value. The financial statements have been prepared in accordance with the Statement of Recommended Practice (SORP), "Accounting and Reporting by Charities" published in October 2000 and applicable accounting standards.

1.2 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors which have been raised by the charity for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

Investment income, gains and losses are allocated to the appropriate fund.

1.3 Incoming resources

All incoming resources are included in the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy. For legacies, entitlement is the earlier of the charity being notified of an impending distribution or the legacy being received.

Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

1.4 Resources expended

All expenditure is accounted for on an accruals basis and has been included under expense categories that aggregate all costs for allocation to activities. Where costs cannot be directly attributed to particular activities they have been allocated on a basis consistent with the use of the resources.

Fund-raising costs are those incurred in seeking voluntary contributions and do not include the costs of disseminating information in support of the charitable activities. Support costs are those costs incurred directly in support of expenditure on the objects of the charity and include project management carried out at Headquarters. Management and administration costs are those incurred in connection with administration of the charity and compliance with constitutional and statutory requirements.

Grants payable are charged in the year when the offer is made except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled. Grants offered subject to conditions which have not been met at the year end are noted as a commitment, but not accrued as expenditure.

1. ACCOUNTING POLICIES (continued)

1.5 Investments

Investments are stated at market value at the balance sheet date. The SOFA includes the net gains and losses arising on revaluations and disposals throughout the year.

Share in subsidiaries are valued at cost less provision for permanent impairment.

1.6 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Freehold property	-	1% to 4%	straight line
Fixtures & Fittings	-	5% to 20%	straight line

1.7 Stocks

Stocks are valued at the lower of cost and net realisable value after making due allowance for obsolete and slow-moving stocks. Cost includes all direct costs and an appropriate proportion of fixed and variable overheads.

1.8 Pensions

The charity operates a defined benefits pension scheme and the pension charge is based on a full actuarial valuation dated 5 April 2001.
